Addendum to Universal Consent Form & Enrollment Agreement
(Learning Modality for 2020-2021 School Year)

During the 2020-2021 School Year, you will have the option to choose between three different learning modalities for your child: Traditional, Hybrid, and Virtual. If you have already selected a modality for the first semester of the 2020-2021 School Year, you do not need to take any action at this time, except to sign this document and return it to the school. If you have not selected a modality or if you would like to change your selection during the School Year, please contact the school at 216-251-5450.

Please know that different expectations apply to each learning modality, all of which are explained below. **Your child's continued attendance in a selected learning modality signifies that you have read and understood the relevant expectations and your associated responsibilities. Traditional Learning Option Expectations:

- Ensure your child's regular attendance at school.
- Send your child to school with a face covering.
- Support your child's homework as assigned.
- Communicate with your child's teacher about their progress.
- Review the gradebook/PowerSchool regularly.
- If your child is feeling ill, has a fever, or is exhibiting any signs of illness, they will be expected to stay home and cannot attend school.
- Your child's temperature may be taken every morning upon arrival at school. If your child has a temperature above 100.4°F or exhibits any signs of illness, you will be asked to come pick up your child immediately. If you do not pick up your child, you may be required to participate in the Virtual Learning Option for the remainder of the semester.
- If your child has a confirmed case of COVID-19, your child must quarantine for 14 days and be symptom free before returning to school.
- If your child has been exposed to someone with COVID-19, your child must stay home from school for 14 calendar days from the date of exposure. Exposure is explicitly defined by the CDC as a "household member OR within 6 feet for at least 15 minutes." Any exposure should be reported to the school so your child can receive instruction virtually.

Virtual Learning Option Expectations:

- Your child will receive at least two hours of direct instruction with a teacher through the ACCEL Management Platform (AMP) each school day. In addition to two hours of direct instruction virtually with the teacher, there will be at least 4.5 hours of additional independent work.
 - All direct instruction sessions will be scheduled in advance. It is expected that your child will attend these sessions so they can work directly with the teacher and their peers.

- Specific times will be communicated to you by your child’s teacher.
- Your child will be required to log in and engage with their teachers and complete all work in order to be counted for attendance purposes each day.
- Your child will receive grades for each class in which they are enrolled.
- You will be responsible for ensuring that the school-owned Chromebook cared for properly. In addition, you will keep the school informed of any technology issues that may impede your child’s ability to complete their learning assignments.
- You and your child will engage in open communication with your child’s teachers and participate in learning activities.
- Breakfast and lunch services will be provided for grab & go meals each week. We will inform you of the pickup day once determined by our food service provider. Your child will be given a lunch break daily.

Hybrid Learning Option Expectations:

- Your child will be assigned two days a week to attend school in person and must be at school to get credit for being present. These days will not change every week. Your child will only be allowed to attend school on their assigned days and will not be allowed to attend on days that are not part of their schedule.
- During Traditional Learning Days, all of the Traditional Learning Option Expectations will apply. If your child is feeling ill, has a fever, or is exhibiting any signs of illness, they will be expected to stay home and cannot attend school, even if it is their assigned day.
- During Virtual Learning Days, all of the Virtual Learning Option Expectations will apply.

This Addendum is in addition to and supplements the Universal Consent Form & Enrollment Agreement you previously completed for your child, the acknowledgements, consents, releases, permissions, and other terms of which are expressly incorporated herein by reference. I understand that my child may be withdrawn from the school, in accordance with state law and school policy if the applicable Expectations explained in this Addendum are not met.
